#### **General Business**

#### **New Commander Surveillance and Response Group (CDR SRG)**

The President advised that the new Commander Surveillance and Response Group (CDR SRG) is Air Commodore Barbara Courtney, AM; she assumed command from Air Commodore Craig Heap on 08 May 2019.

#### Eligibility of 10 Squadron Members to Join MSA in the Future

The President noted that, in alignment with its new role as an intelligence, surveillance and reconnaissance (ISR) specialist squadron, command of 10 Squadron has officially transferred from No 92 Wing to No 42 Wing.

Therefore, strictly speaking, 10SQN is no longer a 'maritime' squadron. We now need to consider the eligibility of future 10SQN personnel to join MSA. Our Constitution states that eligibility extends to 'All personnel who have served in a maritime wing or squadron ...' and 'All personnel who have served in a RAAF squadron associated with a maritime squadron or served in a RAAF unit associated with maritime duties'. Are we happy that 10SQN continues to meet these criteria or do we bring in a cut-off date, whereby only those people who were members of 10SQN before 2 May 2019 are eligible to join? We are not asking you to make a decision immediately. We are merely flagging this situation and we will probably conduct an on-line poll of all members next year.

#### **Guidelines for State Representatives Organising MSA Functions**

The President advised that, in response to a few queries from some State Reps and other members re MSA policy on who pays for what, we are developing some guidelines for those who may be organising MSA functions. They are based on previous policy and custom and are intended to ensure an equitable distribution of MSA funds to our members.

Essentially, all costs associated with any particular MSA function must be covered primarily by those attending. While the MSA provides a subsidy for each financial member (and one guest/partner) attending, it would be inappropriate (and inequitable) to make any further contribution from MSA funds. Our organisation (and our funding base) is too small to provide subsidies for anyone other than financial members and we need to be very careful controlling our outgoing funds to preserve our future financial position

The cost charged per head for an MSA function needs to cover venue hire (if applicable), food and drinks, and any costs associated with a guest speaker (including audio visual support, if required).

If a guest speaker is not an MSA member, their meal costs (and those of their partner, if also invited) must be met from within the payments made by those attending, as part of the overall cost of the dinner. This probably means cutting back on the money available for drinks and/or adding an extra few dollars per head on the price paid by members attending to cover such costs. If the speaker is an MSA member, they are expected to pay for their own attendance (and for their partner) as for any other attendee. We cannot support the payment of a member's dinner simply because he gives a talk.

Once the State Representative has calculated the overall cost per head (to cover food, drinks, and guest speaker and venue hire, if applicable), the amount to be paid by the individuals attending can then be determined. This cost is further broken down to a member and a non-member rate; the difference reflecting the amount of the MSA subsidy.

- MSA Member Rate. The MSA member rate applies to financial members and one partner/guest attending a function. If a member invites more than one guest to a function, the additional guests will be charged at the non-member rate.
- **Non-Member Rate.** The non-member rate applies to all those attending a function who are not members of MSA. This includes additional guests, former members of MSA who are unfinancial and any other persons, such as tour guides.

#### 2020 Canberra Dinner

The date for annual 2020 MSA ACT Dinner next year has still to be finalised. However, at this stage it looks like it will be held on either Saturday 7 or 14 March 2020, at Rydges Capital Hill.

#### **Next AGM Venue & Date**

Barry Collins advised that the date for the next Brisbane Dinner would be 24 Oct 2020. The President declared the meeting closed at 1845 hours.

MSA is in a sound financial position. The combination of membership fees and sale of merchandise is helping offset the costs of the organisation. The working account is slowly reducing, but is coming off a high level, as a result of a draw down made in the previous financial year. The majority of the costs are the subsidy of our functions through the year.

The intention is to allow this to fall further to maximise the earnings in the interest bearing account, it will then be topped up to the required level.

Very low interest rates are affecting our ability to provide extra subsidy to our members. During the period of this report 2.54%was achieved for less than 12 month periods. The new rate is expected to be 1.45%.

# News from here and there

# P-8A part of strait commitment



DEFENCE will commence support to the international maritime security construct in the Strait of Hormuz before the end of 2019.

The announcement, made jointly by Prime Minister Scott Morrison and Defence Minister Linda Reynolds on August 21, committed a "modest, meaningful and time-limited" contribution to the mission.

It will include a P-8A Poseidon (pictured) for one month before the end of the year, HMAS Toowoomba for six months from January 2020 and attachments to the Bahrain-based headquarters. The deployment will enhance Defence's commitment to counter-piracy and counter-terrorism under Operation Manitou.

**Boeing** has received awards worth \$34.5 million to deliver a sixth mission crew workstation retrofit to previously delivered US Navy and Royal Australian Air Force P-8 Poseidon maritime patrol aircraft.

A total of 60 aircraft will be modified under the contracted work, expanding the crew size from five active operators to six, which will increase the mission capability.

More operators will result in more functions being able to be performed, and more functions means more data collected and therefore increased mission effectiveness, Fred Bruner, P-8 programme manager at Boeing, said.

The retrofit will additionally bring existing operational aircraft up to the same crew configuration as recent production aircraft, including the four aircraft due to be delivered to the Royal New Zealand Air Force, which already include a sixth workstation.

#### **RAAF Base Townsville Works**

Runway extension. The proposed runway extension will increase the take-off distance to 2844 metres (9331ft) allowing the P-8A Poseidon to take off at maximum-all-up-weight at ambient temperature up to 34°C.

Redevelopment of existing Maritime Ordnance Loading Aprons 13 and 14. Minor pavement extension works is proposed at the Maritime Ordnance Loading Aprons to accommodate movement of ground support equipment around the aircraft.

**Aircraft rinse facility.** An aircraft wash facility is proposed to be constructed to provide regular rinsing of the aircraft to reduce the build-up of airborne contaminants arising from low flying operations.

#### RAAF-funded project testing SAR capability for P-8A Poseidon

A Royal Australian Air Force (RAAF)-funded project is testing an extended search and rescue capability for the P-8A Poseidon.

The study is being conducted off the coast of the Naval Air Station Patuxent River (PAX) in Maryland and is evaluating the UNIPAC III Search and Rescue (SAR) kit on the P-8A maritime patrol aircraft.

The US Navy's Naval Air Systems Command (NAVAIR) revealed that the kit will enable the P-8A to provide survivor assistance to 100 people in a single sortie. Naval Technology

#### Argentina P-3s

The U.S. State Department has approved Argentina's proposed purchase of four ex-U.S. Navy P-3C patrol planes. The \$78-million P-3C deal, which the State Department approved in late December 2019, includes the four airframes plus spare engines and all the electronics and support systems. The used P-3Cs would replace six older P-3Bs in Argentine naval aviation. None of the P-3Bs are operational, the State Department noted.

#### RAAF P-8A completes Middle East mission

The Royal Australian Air Force P-8A Poseidon aircraft that deployed to the Middle East in October has completed its mission successfully, the Australian Department of Defence announced on 25 November. The aircraft took part in International Maritime Security Construct (IMSC) missions to ensure the safe passage of naval and merchant vessels through the region and boost maritime security.

#### RAAF joins surveillance effort against North Korea

Australia is sending a maritime patrol aircraft to Japan to join an international effort to enforce United Nations Security Council imposed sanctions against North Korea. The deployment of the P-8A Poseidon maritime patrol aircraft is the fifth to occur since April 2018.

#### Poseidon's soar at Talisman Sabre

The P-8A Poseidon played a starring role in Exercise Talisman Sabre, operating out of RAAF Base Williamtown for the duration of the Exercise.\_More than 140 personnel from both Australia and the United States made up the P-8A Detachment. Four aircraft – two from each nation were based out of the Australian Mobile Tactical Operations Centre (MTOC).

For three weeks 11 Squadron and VP-5 (The Mad Foxes) flew a variety of sorties and were put through different scenarios including anti-submarine warfare (ASW) missions.

Officer Commanding 92WG, Group Captain John Grime flew on one of the ASW missions and said conducting ASW in support of a Carrier Strike Group is a challenging and complex role that is only fully exercised during large exercises like Talisman Sabre. Mirage News

#### Royal Air Force Poseidon

The Royal Air Force expects to declare initial operational capability with its new Poseidon MRA1 fleet during 2020, with its lead example to arrive in the UK "in early-spring".

"All nine aircraft will be delivered by November 2021, with full operational capability [to be] achieved in 2024," the service says. The type will be home based at RAF Lossiemouth in Scotland, although runway resurfacing work at the facility will require flights to be performed from nearby Kinloss during 2020.

Once operational, the P-8A fleet will be supported by 18 frontline crews assigned to two units: 120 Sqn, which was re-formed in April 2018, and 201 Sqn.

The service has lacked dedicated maritime patrol aircraft since the retirement of its BAE Systems Nimrod MR2s in 2010.

# RAAF receives final P-8A Poseidon maritime surveillance aircraft

Australia's newest maritime surveillance aircraft, the P-8A Poseidon, has arrived at its new home, RAAF Base Edinburgh on 12 December 2019, completing the fleet for No. 11 Squadron.

The RAAF has committed to acquiring 15 P-8A Poseidon aircraft. Up to now, 12 P-8A Maritime Patrol Aircraft have been approved for acquisition, and three are subject to normal Government Defence acquisition approval processes.

As a direct commercial sale, India has received eight of the P-8I variant to date with four more in production. The U.S. Navy is on contract to receive 111 with the potential for additional quantities based on the fleet's needs. As a cooperative partner with the Maritime Patrol and Reconnaissance Program Office, Australia began receiving their P-8A aircraft in 2016.

The United Kingdom is one of six international customers for the P-8A Poseidon and the first has been delivered; Norway will begin receiving their five P-8As in 2022; both New Zealand and South Korea have signed agreements with the U.S. Navy to purchase four and six aircraft respectively.

#### **Bush Fire support**

# <u> History Corner</u>

No 10 Squadron was officially incorporated into No.15 Group, RAF Coastal Command on 3 January 1940 and declared operational from 1 February 1940.

#### 10 Jan 68 - RAAF accepted first P-3B Orion

The prototype Lockheed Orion maritime patrol aircraft, designated YP3V-1, serial 148276, flew on 25 November 1959. New Zealand became the first export customer with an order for the upgraded P-3B version. In November 1964 the RAAF selected the Orion to replace the Neptunes of No 11 Squadron at RAAF Base Richmond. These ten aircraft -- A9-291 to A9-300 -- were P-3B-95-LO and -100-LO variants. The first aircraft, A9-291, was accepted by the RAAF on this day and arrived at RAAF Edinburgh on 13 May 1968.

Seventeen years later the last RAAF P-3B took off from Edinburgh on 24 Jan 1986 for Lockheed's Burbank factory. The P-3Bs were traded for new P-3C aircraft. The first retired aircraft became the prototype of the proposed AEW Orion.
